In adopting my dog, I agree to the following:

- 1) I do not live in nor will I move to a building or community whose restrictions on the number, breed or size of pets interfere with my fulfilling my commitment to this dog.
- 2) I will provide a safe and loving home for my dog. Adopter agrees the dog is to be a family companion and agrees to provide the dog with a safe home, adequate food, water, proper care, exercise, love and attention. Adopter agrees not to violate any laws or ordinances with the dog. The dog is not to be used as an attack or protection trained dog and will not be used for commercial guard work.
- 3) I agree to keep a collar on the dog at all times and acknowledge that legally dogs are required to have a collar with current rabies tag / town dog license. Due to risk of accidental choking we recommend not using choke collars outside of training and walks.
- 4) I agree that the dog will be confined inside the home or in a fenced outside area with adequate shelter when no one is at home. If I am to go away for a prolonged period of time or vacation, I will prearrange proper care for the dog.
- 5) The dog is not to ride loose in the bed of pickup trucks, convertibles or to be left in a car when air temperatures exceed 70 degrees.
- 6) I agree to have a clean, secure fenced area for the dog. If a fenced enclosure is not available, I agree to leash walk dog. If I will use invisible fencing, the dog is to be sufficiently trained before releasing it inside the system. Under no circumstances is the dog to be kept routinely on a runner or tie out.
- 7) I will provide my dog with proper food, water, shelter, training, exercise, attention, and medical treatment as necessary. I will provide lifetime care, including annual Veterinary exams, vaccinations, and booster shots, and immediate medical attention when necessary.
- 8) If I can no longer provide adequate care for my dog, I agree and commit to return my dog directly to Dust Bowl Animal Rescue. I understand that to the best of Dust Bowl Animal Rescue's knowledge, the dog I am adopting is in good health (unless problems are specified) and that I have been provided such health records as Dust Bowl Animal Rescues provides. I will not hold Dust Bowl Animal Rescue liable for any future medical bills my cat may incur.
